VEHICLE CODE

§ 70.05 MICHIGAN VEHICLE CODE ADOPTED.

The Michigan Vehicle Code, Public Act 300 of 1949, being M.C.L.A. §§ 257.1 through 257.923, is adopted by reference.

UNIFORM TRAFFIC CODE

§ 70.10 MICHIGAN UNIFORM TRAFFIC CODE ADOPTED.

The Uniform Traffic Code for Cities, Townships and Villages as promulgated by the Director of the Michigan Department of State Police pursuant to the Administrative Procedures Act of 1969, Public Act 306 of 1969, being M.C.L.A. §§ 24.201 through 24.328, and made effective October 30, 2002, and all future amendments and revisions to the Uniform Traffic Code when they are promulgated and effective in this state, are incorporated and adopted by reference.

§ 70.11 DEFINITIONS.

References in the Uniform Traffic Code for Cities, Townships and Villages to a "governmental unit" shall mean the City of Ferrysburg, Ottawa County, Michigan.

No officer, agent, or employee of the city shall be personally liable for any damages the city may accrue to any person as a result of any act required or permitted in the discharge of duties under and in the enforcement of the Uniform Traffic Code for Cities, Townships and Villages.
