The City of Ferrysburg now accepts voluntary Automatic Bill Payments for utility and/or property tax bills. Once you enroll in the program, your bills will be paid directly from your checking account. **Payments will be drawn from your account on the scheduled payment date.**

There are several benefits to enrolling in the Automatic Bill Payment Program.

- \* Payments are not delayed or lost in the mail.
- \* Utility and/or Property Tax bills are paid on time.
- \* Late charges are eliminated.
- \* Bills are paid while you are out of town, on vacation or gone for the winter season.
- \* Automatic Bill Payment is simple to initiate.

Please fill out the Property Tax ID# if you want your tax bill automatically paid and fill out the Utility Account # if you want your utility bill automatically paid.
